The Bradford County Board of County Commissioners convened to conduct the final public hearing to adopt the fiscal year 2012-2013 millage and budget on Monday, September 17, 2012, at 5:30 p.m. in the County Commission Chambers, 945 North Temple Avenue, Starke, Florida.

**CALL TO ORDER:** Chairman Chandler called the Public Hearing to order at 5:32 p.m.

---

**ADOPTION OF FINAL MILLAGE RATE:**

The Fiscal-Year 2012-2013 operating millage rate for Bradford County Board of County Commissioners is 9.1769 mills. The rolled-back rate is 9.5002 mills.

Chairman Chandler gave the breakdown of the final millage rate of 9.1769 mills as follows:

GENERAL FUND	6.9065 mills
FINES & FORFEITURE FUND	2.0000 mills
EMERGENCY MEDICAL SERVICES FUND	0.1647 mills
HEALTH DEPARTMENT TAXES	<u>0.1057 mills</u>
TOTAL	<u>9.1769 mills</u>

This is expected to generate approximately \$7,409,966.
